

List of the goods prohibited for transportation as per the International Express shipping tariff

- firearms of all types and the related ammunition, cold weapons of all types, military munitions;
- narcotic, psychotropic, radioactive, explosive, poisonous, flammable and other dangerous substances;
- Russian and foreign currencies, other currency assets and other assets;
- public bonds of the Russian Federation, lottery tickets;
- print and audiovisual materials, other visual products that may cause damage to the national interests and infringe the rights of citizens;
- stones, semiprecious raw materials, minerals, rocks, soil, paleontological samples, rough and cut semi-precious stones, amber;
- precious metals in any form and condition, rough and cut natural and precious stones, pearls and pearl products;
- all species of animals, insects, fish and mammals in any form;
- unprocessed photosensitive materials;
- items of cultural value created more than 100 years ago;
- obscene objects, pornographic materials;
- foods, canned foods, confectionery and any products and additives used in the food industry;
- identification documents (Russian and international passports, military IDs and marine certificates);
- driving licenses;
- dangerous goods;
- plants, seeds, planting materials and other plant products subject to quarantine
- any item that can be dangerous for workers or can stain or spoil other items due to its nature or packaging;
- biological tissues and drugs (blood, plasma, DNA samples);
- any home-produced devices, spare parts and equipment (produced by individuals);
- all types of liquids;
- products listed in Heading 71 of the Foreign Economic Activity Commodity Classification: natural and cultured pearls, precious or semiprecious stones, precious metals and products made of them, costume jewelry, coins;
- unaccompanied cargo (the full names of the sender and the recipient are the same);
- ivory and ivory products;
- tobacco and tobacco products (bulk tobacco, liquid for electronic cigarettes, sticks for electronic vaporizers);
- alcohol products;
- rechargeable batteries not installed in devices;
- refrigeration equipment and spare parts for it;
- dual-use goods (spare parts for UAZ, GAZ and MAZ vehicles) *only upon agreement with coordinators of the International Logistics Department;
- watches and clocks (wrist watches, wall and tables clocks, etc.) with the value over USD 500;
- fragile glass products.

Also, keep in mind:

Not implemented:

- temporary export and import of goods
- transportation of goods requiring special equipment, precautions or permits
- delivery to the subscriber box (P.O.Box)
- customs transit of goods

Limitations of the countries for the import of certain categories of goods:

The import of drugs:
Mexico, Spain, Israel, Italy.

The import of drugs to natural persons:

Poland, Latvia.

To send medications to the territory of Ukraine, Georgia, Azerbaijan, China, Spain, Turkey and the Czech Republic, it is necessary to provide a doctor's prescription for all drugs and authorization to import the drug from the Ministry of Health of Ukraine.

When sending any medical preparations and cosmetics to any country, the recipient must first contact the local customs office and clarify the possibility of importing these products and the list of documents that will be required for customs clearance.

Azerbaijan: the import of mobile phones is prohibited;

Canada: the import of baby walkers, electronic cigarettes and spare parts for them, paintball equipment is prohibited;

China: import of electronic cigarettes and spare parts for them, toys in the form of weapons is prohibited;

Ukraine: it is forbidden to import any goods made in Russia;

France: import of "sleep hormone" Melatonin, Caviar phones, creatine is prohibited;

Spain: the import of cosmetics to individuals is prohibited;

Turkey: the import of mobile phones to individuals is prohibited;

USA: Xenon headlights prohibited.
